## APPLICATION FEE

Parents/guardians may register their child by completing an Application Form and paying a fee of \$150 (includes GST). This fee covers administrative costs and is non-refundable. On payment of the Application Fee, the child is placed on our wait list.

## STANDARD FAMILY CONTRIBUTION (SFC)

Each family pays a non-refundable Standard Family Contribution (SFC) at the time of acceptance of the first child's enrolment and is payable to the Gabriel Foundation. The SFC is not tax deductible. The purpose of this contribution is to assist with the ongoing development of the School. This is a single payment if the student is entering the Senior School and is payable in two instalments if entering the Junior School and three instalments if entering the Early Learning Centre to a maximum of \$3,350.

### Fees in Advance

A 2% rebate is offered on fees paid four terms in advance, subject to payment being received by the School on or before first day of Term 1 (31 January 2017).

### Payment of Fees

ELC – Tuition and Outside of School Care are invoiced fortnightly in arrears in accordance with government requirements for those eligible to receive the childcare benefit and/or child care rebate.

All other fees and charges are payable by the first day of each term. Fees are non-refundable and are not subject to pro-rata payment.

An Overdue Fee Charge will be levied on amounts outstanding after that time. The charge is \$55 if the unpaid balance is less than \$1,000, \$110 if the unpaid balance is greater than \$1,001 and less than \$2,000; and \$220 if the unpaid balance is \$2,001 or more. Any parent facing difficulties with the payment of fees should contact the Chief Operating Officer on 02 6202 6400.

School fees may be paid by:

- ▶ cash
- ▶ cheque
- ▶ BPay (details appear on the fee statement)
- ▶ fortnightly direct debit over a period of 26 fortnights.
- ▶ credit cards (MasterCard, Visa and AMEX).

### Notice of Withdrawal or Change from Boarding to Day Student


A term's notice of intention to withdraw a student from the School **or to change from day to boarding or vice versa**, must be given in writing to the Principal, otherwise half a term's fees will be charged in lieu of notice should the School not be able to fill the place.

A term's notice must also be given in writing to the Principal of intention to withdraw a student from the School for a limited period of one term or more. Half a term's fees will be charged should the School not be able to fill the place for the period of absence. Re-entry to the School after absence of more than one term is dependent upon a place being available. Due fees apply for absences of less than one term.

A half term's notice must be given before a student discontinues a co-curricular subject (eg private lessons for music, speech or dance tuition etc); a half term's fees will be charged in lieu of notice should the School not be able to fill the place.

### GST

The School reserves the right to charge GST on all taxable supplies.
